#### ABOUT US

Society for the Aged Sick (SAS) is a not-for-profit Nursing Home with a licensed bed capacity of 407. The Home provides residential services to people in need of daily skilled nursing care and/or assistance in activities of daily living, and who cannot be cared for at home, particularly the less privileged.

We provide a range of services to meet the needs of our residents. They include medical care, nursing care, physiotherapy, occupational therapy, and dietary services.

Our social service team together with dedicated volunteers, also provide emotional support and organise activities.

#### **OUR HISTORY**

The history of our Home goes back to the year 1965, when two sisters, Teresa Hsu and Ursula Khow, founded the Home, then known as "Welfare Resthome". The Home was set up to care for the aged sick and destitute in the community. Ms Teresa Hsu took the helm as the first matron of the Home.

In 1968, management of the Home was taken over by Mr George Gray Thompson and a group of friends from the Rotary Club of Singapore. Together, they established Society for the Aged sick to cater to the expansion of the Home.

In 2023, we celebrated our Home's 55th Anniversary. From humble beginnings, we are grateful for the overwhelming support from our community to help us keep our not-for-profit Nursing Home running. At present, the Home caters to nearly 400 residents who reside on our premises and are cared for by nursing and care staff round the clock.



#### **ROLE OF THE EXECUTIVE COMMITTEE (EXCO)**

The EXCO's role is to provide strategic direction and oversight of SAS programmes and objectives and to steer it towards fulfilling its vision and mission through good governance. As part of its role, the following matters require EXCO's approval:

- Approve budget for the financial year and monitor expenditure against budget;
- Approve audited annual financial statements;
- Regularly monitor the progress of SAS' programmes;
- Strategic planning;
- New policies and revisions to existing policies;
- Award of vendors for expenditure exceeding \$20,000

#### **EXCO ELECTION AND TERM LIMIT:**

Under SAS's constitution, EXCO members are to be elected at alternate Annual General Meetings. Each term that a Member of the EXCO serve is for a period of about 2 years ("Term"). However, the maximum term limit for the Treasurer should be four consecutive years and the President is not eligible for re-election as President beyond three consecutive Terms. The current term of all the EXCO members in office as at the date of this report shall continue until the SAS's annual general meeting in September 2024. The EXCO has approved a policy and strategy pertaining to board renewal under which succession planning has to ensure that the EXCO continue to possess the appropriate blend of skills, experience and expertise to support the SAS's mission, objectives and strategies on an on-going basis.

Dr. Timothy Teoh, Mr Chew Loy Cheow, Dr Richard Tan, and Mr Yeo Chuen Eng, have each served on the EXCO for more than 10 years. For their respective skill sets and expertise which are elaborated upon in the table next page, and on the recommendation of SAS's Governance Sub-Committee, it is the EXCO's desire for them to remain serving as members of the EXCO so that SAS can continue to benefit from their invaluable contribution.

#### **EXCO TRAINING AND EVALUATION**

Governance Committee will ensure that:

#### EXCO SELECTION PROCESS AND STRATEGY

Prior to the expiry of each term, the Governance Committee will review and make recommendations to the Board with respect to Board composition to ensure that the Board continues to have the appropriate mix of skills, experience, and expertise. The review will take into account the following:

- The annual Board effectiveness review.
- The contribution and performance of each Board member.
- Compliance with SAS's Code of Conduct.

Subject to the specific requirements of the constitution, Board members are generally expected to serve for no more than five consecutive Terms but a Board member may on the recommendation of the Governance Committee be requested by the Board to serve for such further periods if the Board determines that such member's skill sets, experience and expertise are necessary for continued support SAS's mission, objectives and strategies.

To ensure succession for Board members, SAS has adopt the following strategies to achieve the Board renewal objective:

- Induction of new EXCO members or Sub-Committee member by the existing EXCO members or Sub-Committee members.
- Leverage on the various agencies
- All new members will serve as a Sub-Committee member before being co-opted to serve as an EXCO member. However, the Board has the discretion to directly co-opt a member into the Board if it determines that his or her skill sets, experience and expertise are crucial for the continued support of SAS's mission, objective and strategies.

(a) New appointees to the Board understand the charitable objectives of SAS, charity law and regulations and the Code of Governance;

(b) New appointees to the Board understand and agree to the time and participation requirements of Board members and understand their duties and responsibilities; and

(c) Policies are developed for new Board member orientation and Board development and training.

Under the Governance Sub-Committee's terms of references, EXCO has to conduct self-evaluation to assess its performance and effectiveness once a term.

#### SUB-COMMITTEES: TERMS OF REFERENCE:

Audit Committee	The AC monitors the integrity of the Financial Statement and reviews the
(AC)	overall scope of the external and internal audit to ensure the adequacy of SAS's internal financial controls. The AC also reviewed the financial statements of SAS and the auditor's report for the financial year ended 31 March 2024.
Finance and Investment	The Finance and Investment Committee is responsible for overseeing SAS' financial operational controls and risk management, budget planning and monitoring, as well as capital asset management. The Committee also oversees the management of reserves and investments to ensure SAS maintains a level of reserves for its long-term financial sustainability.
Fundraising	The Fundraising Committee has oversight of all the charity's fundraising activities and to ensure compliance to all applicable laws and regulations. The Committee shall also ensure the fundraising activity by the third party is in accordance with the Society's objectives.
Governance	The Governance Committee helps to shape the governance of SAS by developing and recommending to the EXCO a set of governance principles, standards, and practices in line with Charity law and the code of Governance.
Home Management and Quality Assurance	The Home Management and Quality Assurance Committee assists the EXCO in establishing, monitoring and maintenance of internal systems and controls to give reasonable assurance that SAS is operated efficiently and with quality control for the safety and dignity of the residents of SAS.
Human Resource	The Human Resource Committee assists the EXCO in establishing, monitoring and maintenance of appropriate Human Resources (HR) and employment matters by ensuring HR policies are set in accordance with applicable laws.
Procurement	The Procurement Committee assists the EXCO in the establishment, monitoring and maintenance of a procurement strategy and systems of internal controls for the purchases by SAS to give reasonable assurance that purchasing decisions are prudent and value for money and purchasing and procurement are done transparently and in compliance with applicable laws.
Information Technology (IT)	The IT Committee assist the EXCO in fulfilling the EXCO's oversight responsibilities with respect to IT activity of SAS. IT Committee ensure SAS' IT programs support SAS' long-term goals and strategic direction, oversee risks related to the quality and effectiveness of SAS' IT data security, data privacy and disaster recovery capabilities and advise SAS' EXCO and management team on IT matters.
Facilities (Building Project Based)	The Committee assist the EXCO on building development and construction at the SAS's premises if the EXCO approves a project for any such development and construction (a " <b>Project</b> ").
MediFund Committee	The MediFund Committee reviews and approves Medifund applications from eligible residents and administers payments out of the Medifund account. In considering any application and authorising any payment, the Medifund Committee ensure all cases are in compliance to the Medical and Elderly Care Endowment Schemes Act (MECESA), its corresponding regulations and any directives and guidelines issued by the Minister and Medifund Account do not go into overdraft at any point.

The remuneration received by the Management Team can be found in **Note 3B** of the Financial Statements. None of the Management Team members serves on the EXCO.

There are no paid staff who are close members of the family of the Executive Head or EXCO members, who each receives total remuneration of more than \$50,000 during the year.

No Management staff is involved setting his or her own remuneration.

#### **CONFLICT OF INTEREST POLICY:**

SAS has a policy regarding conflicts of interest which requires (among other things) prompt declaration of any actual or potential conflict of interest in respect of any proposed transaction involving SAS and exclusion from discussions and decision making on the proposed transaction. The policy further provides that the proposed transaction may only be undertaken if there is a competitive bid or comparable valuation and the EXCO determines that the proposed transaction is in the best interests of SAS.

#### WHISTLE BLOWING POLICY:

SAS has established a whistle-blowing policy to address concerns about possible wrong-doing or improprieties in financial or other matters within the Home.

#### **VOLUNTEER MANAGEMENT POLICY:**

To ensure that residents of the home receive holistic care during their stay here with us, we also provide a range of other services to meet their needs.





The reserves that we have set aside provide financial stability and the means for the development of our charitable activities. We intend to maintain our reserves at a level which is equivalent to 12 months at the very least. We intend to use the reserves in the following manner:

- to meet unexpected expenditure or contingencies
- to cover for delays between spending and receipt of donations or grants.

The EXCO regularly reviews the amount of reserves that are required to ensure that they are adequate to fulfil our continuing obligations.

#### **Purposes of restricted funds:**

#### (i) **Building Reserve**

This is meant for the renovation, maintenance and payment for repair services of the leasehold building.

#### (ii) Computerization Fund


This is to be used for SAS' IT system upgrades.

#### (iii) Bob and Hazel Booker Memorial Fund


(previously named as R.K. Booker Memorial Fund) This is used for giving out scholarships and training for SAS' staff.

### FINANCIAL HIGHLIGHTS OF THE YEAR



For the financial year ended 31 March 2024, SAS generated a surplus of \$2,116,339. This is about \$1m higher than our previous financial year.

The increase in surplus is mainly due to increase in occupancy rate and government grant to support the healthcare sector salary adjustment. The increase is partly offset by increase in manpower costs and operating costs.

#### 1. Income

The increase in income is mainly due to increase in occupancy rate and government grant pertaining to the healthcare sector salary adjustment. Higher donation and interest generated from our fixed deposits and investment also contributed to the increase.

#### 2. Expenditure

Operating costs increased by about \$2 million mainly due to higher manpower costs, increase in occupancy rate and the costs pressure from external factors.

Manpower cost increased by about \$830,000 as compared to FY2023. This is due mainly to the increase in foreign worker levy, salary adjustment to recruit and retain our healthcare workers.

Other costs like resident nursing cares costs, facilities management, maintenance & other ancillary costs have increased by about \$1 million due to higher occupancy rate and to provide better quality of service to our resident. Impact from external costs pressure has also contributed to the increase of our operating costs.

#### MAJOR FINANCIAL TRANSACTIONS DURING THE YEAR

SAS' cash and cash equivalents decrease by \$540,827 (3%) during the year mainly due to investment in money market fund during the financial year. This is partly offset by the operating surplus generated during the year.

#### PURPOSE OF CHARITABLE ASSETS HELD

Total assets held by SAS amount to \$38,574,044 as at 31 March 2024, of which

(i) \$17,500,208 or 45% is held in the form of cash and fixed deposits. Of this \$13,945,060 is placed with fixed deposits.

(ii) SAS has invested total amount of \$5,500,000 in Money Market Fund. These investments are classified and measured at fair value through profit and loss (FVTPL) as required by FRS 109. SAS has recognised fair value gain of \$143,886 (2023: 7,595) from investment in the profit or loss. Fair value for the investment as of 31 March 2024 is \$5,651,481.

(iii) \$8,650,970 (22%) is held in the form of property, plant and equipment.

These include the leasehold building at 130 Hougang Avenue 1 where the Home is located, vehicle and furniture and equipment that support the operations of the Home.

(iii) \$5,111,255 (13%) is the prepayment of lease renewal premium to Singapore Land Authority for the 30-year lease from 1 September 2018 to 30 August 2048.

In the year ahead, we have plans to perform cyclical maintenance and renovation of our home to provide better facilities for our residents and better support our operations. They include repainting, replacement of old carpentry and repurpose of spaces to resident activity rooms and storage facilities. Aside from the application for government grants, we will also be raising funds to defray the cost of this project.

## AWARDS



It is with great pride that we present four of our Senior Nurses (SNs) as recipients of the prestigious Resilience Medal. During the pandemic, these four SNs have contributed their skills, time, and resources to help in the fight against COVID-19. The Resilience Medal award acknowledges the individuals who were substantially involved in managing the challenges posed by COVID-19 at the organisation.

#### SENIOR NURSE (SN) Amplayo Ethel May Ancog:

SN Ethel proactively volunteered her off-duty time, even late hours into the night. She would collect swab specimens from residents and personally send them to the National Public Health Laboratory (NPHL). Her monitoring of with residents' conditions closely strictly implemented infection prevention control measures in the ward, greatly minimised the infections in the ward.

#### SENIOR NURSE (SN) Musni Christina Solmayor:

In our Home, SN Christina played an integral role in ensuring we were well stocked on medical supplies and that all staff under her care were adhering to pandemic protocols in the wards. She also went beyond her call of duty and contributed aid to other shorthanded nursing homes during the pandemic.

#### SENIOR NURSE (SN) Saludes Cherese Joy Romulo

Just like her namesake, SN Joy is known for her positive attitude and dedication to providing quality care to residents. During the pandemic, she also willingly volunteered to be deployed to other organisations in lieu of their manpower shortage.

#### SENIOR NURSE (SN) May Zin Po Myint

During the pandemic, SN Zin Po's involvement was crucial in drawing up isolation zones to prevent the further spread of the infection. Her commitment also extended beyond her working hours as she ensured her ward was running smoothly and infected residents were well taken care of.

1 September 2023 was polling day for all Singaporeans, but it was extra special for us. This was the first time polling stations were set up in several nursing homes across Singapore, with SAS being one of them. This inaugural experience was extremely beneficial for our residents with the more accessible voting set up.

Four polling stations were set up in the Home's premises, allowing our wheelchair-bound residents to vote with ease. Our bedbound residents were also able to vote this round with the assistance of election officials at their bedside. This new setup in our home made the voting process smoother and much more convenient for us.

News agencies like Channel News Asia also came down to our Home to report on the new voting process and interview our residents.

Our residents, Mdm Lee and Mdm Chua, spoke about how the voting process had been easier in comparison to the previous years' which had required them to make special arrangements for wheelchair-accessible transport and accompanying care staff to bring them to the allocated venues to queue and make their vote.

Our COO, Ms Kate Koh, gave an interview providing more insights on the logistics ongoing behind the scenes. Nurse Clinician, Molly, can also be seen on the news assisting polling officials with the simulation of the voting process in the home.

This change in the voting process shows how Singapore is taking a step towards being more inclusive of the population that are more disadvantaged. Allowing them to exercise their rights (or should it be civic duty) gives them the opportunity to be part of the country's future.

## **ORAL WELLNESS**

From May to July 2023, the dental team from Tzu-Chi Singapore performed pro bono dental screening and procedures for all our residents. The CASA-MODAL project (Clean And Screen All Mouths Of Disability And Long-term care facilities) started by Tzu-Chi Singapore, aims to provide accessible dental services to those with disabilities or who are housed in longterm care facilities. The dental procedures included: Screening, Examination and Diagnosis, Dental brushing, Silver Diamine Fluoride (SDF) application, Denture soaking, and DURAPHAT application.

A designated station was set up in the home for wheelchair-bound residents to receive dental procedures. For residents who were bedbound, the team from Tzu-Chi would carry out the procedures by their bedsides in the ward. The team was incredibly caring and patient in their interaction with our residents, allowing even some of our more anxious residents to open up and be open to receiving dental treatment.

Words cannot express how grateful we are that they managed to provide dental care to 347 of our residents over the course of three months.

### COLLABORATION WITH ST LUKE'S HOSPITAL

It is crucial that our nurses are constantly building skills and staying updated in the medical field to better provide for our residents. Since January 2023, SAS has been collaborating with St Luke's Hospital regarding wound care to reinforce our clinical care. Chronic wounds are predominant among the elderly and with the help of St Luke's nurse clinicians sharing their treatment plan and procedures, our nurses are better prepared to help our residents heal successfully.



### INTERNATIONAL DYSPHAGIA DIET STANDARDISATION INITIATIVE (IDDSI)



Dysphagia, or swallowing difficulties, is a prevalent condition with age. This affects one's ability to intake food and fluids. To ensure a common understanding and safe implementation of the IDDSI framework across the board, our care staff have gone through several rounds of training by our Nurse Educator, Ms Wendy Teo. During her workshop, she uses games, mini quizzes and tests. She makes sure all our staff are familiar when dealing with the various diets of our residents.

Together with our speech therapists, dietitians, and nursing home aids, we work to create a safe environment for all our residents.



## SILVERFIT

The Silverfit 3D is a virtual therapy system that our rehab team has recently added to their exercise program. Used to train gross motor skills and activities of daily living (ADL) tasks, this software platform facilitates physiotherapy rehabilitation through specially designed virtual games.

Many of our residents have expressed keen interest in participating in this activity that involves technology they have not encountered. Those who have gone through a few sessions remarked that they enjoy it thoroughly.



## **SENSORY ART**



Sensory Art is a form of art therapy that explores one's creativity while stimulating their senses.

Throughout the year, our Resident Care Assistants under the Medical Social Service team have conducted several such art sessions for our residents. Using art materials of various textures, their senses are engaged through the art-making processes. This not only helps them to practise their motor skills, it can also enhance positive mental wellness by altering their physiology and attitude.

## SPIRITUAL SUPPORT

Many of the religious fellowships are conducted with the voluntary support of religious organisations, and for that we are ever thankful. These fellowships not only help our residents on a spiritual level, the volunteers are also able to form meaningful bonds with our residents in the congregation.

We are glad to be extending the support towards our residents on a spiritual level and look forward to partnering with more religious organisations to cover other religious denominations in the upcoming year.











## **SPIRITUAL SUPPORT**





As part of the spiritual outreach towards residents, on 7 March, with the much-needed help of our volunteers, we were able to bring some of our Buddhist residents to Kong Meng San Phor Kark See Temple. Located on Bright Hill Road, this is the biggest temple in Singapore.

This religious trip helped to fulfill our residents' expressed wishes to offer their prayers in person. At the temple, they were able to participate in ongoing mass prayers, a practice that is of importance to them and one that we believe can bring them some inner peace.

Our gracious hosts also brought our residents on a tour of the different sites and shrines on the temple grounds. This enriching religious excursion was concluded with a communal vegetarian meal amongst fellow visitors of the temple.

We would like to thank our volunteers, especially Ms Ng Saw Hoon (she is also our residents' Nagomi art teacher) who graciously covered the costs of the wheelchair transport that ferried our residents and volunteers to and from the temple.

### HONOURING LOVE AND LOSS

At SAS, we believe that care extends beyond physical assistance to encompass empathy for our residents and their families during times of grief and loss. In addition to counselling, our social workers have facilitated the attendance of several residents at the funerals of their loved ones as well as the funerals of fellow residents.

Though logistical arrangements can pose challenges, our MSS team strongly advocates for the importance of attending funerals as a vital component of the grieving process — not only for our residents but for all involved. We also had a few occasions where our staff attended the funerals of residents that they had grown close with over the years. Being present allows them to pay respects, cherish shared memories, and bid a final farewell alongside others who held significance in their loved one's life.



## **INTERGEN PROJECT**

The Intergen project, short for intergenerational project, between SAS seniors and students aims to promote and cultivate social inclusivity within our community. Our Rehabilitation team partnered with PCF Sparkletots @ Sengkang and St Johns' Brigade to have young volunteers between the ages of 3-16 engage with our senior residents. Together, they helped to conduct the daily occupational therapy activities like arts and crafts, gardening, singing, upper body exercise, and dancing.

Our residents had a fun time interacting with the younger generation and it was certainly a learning experience for the young students. Getting a chance to interact and help out our residents, they were able to experience firsthand how we can always include everyone by making a little adjustment or modification. We hope that inculcating this at their young age will allow them to further the socially inclusive mindset.
